Definitions

“Corporate” (Type of Organization)	Companies that have an annual turnover of 10 million Euro or more.
“SME” (Type of Organization)	Companies that have an annual turnover of less than 10 million Euro.
“Not-for-profit” (Type of Organization)	Organizations that do not distribute their surplus funds to owners or shareholders now and/or in future, but instead use them to help pursue their goals.
“Application Fee”	Fee related to GRI’s assessment of the application.
“GRI GOLD Community Fee”	Membership fee for joining the GRI GOLD Community.
