<b>“Corporate”</b> (Type of Organization)	Companies that have an annual turnover of 10 million Euro or more.
<b>“SME”</b> (Type of Organization)	Companies that have an annual turnover of less than 10 million Euro.
<b>“Not-for-profit”</b> (Type of Organization)	Organizations that do not distribute their surplus funds to owners or shareholders now and/or in future, but instead use them to help pursue their goals.
<b>“Application Fee”</b>	Fee related to GRI’s assessment of the application.
<b>“GRI Community Fee”</b>	Membership fee for joining the GRI Community.
