Position summary and purpose

The Standards Division is responsible for developing and maintaining the world's most widely used standards for sustainability reporting..

You will be primarily responsible for providing research inputs to the development of GRI Standards, as well as other activities of the organization. This will be done through a combination of desktop research, direct interaction with experts and analysis of feedback from stakeholders. Your responsibilities may also include supporting the writing and revision of content for the standards and project management activities.

You will report to the research lead and will support the project managers in the development of these three standards. For this you will prepare a variety of documents and deliverables.

The post holder will have the opportunity to be involved in a range of sustainability content areas and develop further understanding the sustainability impacts of various sectors.

The ideal candidate will be organized and detail-oriented, and will be able to work independently as needed, balancing and prioritizing multiple tasks. The candidate will also have strong research and analytical skills, as well as excellent written and verbal communication skills.

Job responsibilities

- Carry out research on a wide range of topics related to the impacts of reporting organizations on the environment, people and the economy.
- Find the most relevant information on specific topics across databases, secondary sources and corporate reports. Ensure Standard content is well evidenced and aligned with authoritative references.
- Interact with team members to understand the research needs and adapt the methodology accordingly.
- Analyse qualitative feedback from expert and stakeholder consultations in accordance with the GSSB Due Process Protocol.
- Synthesize and present findings for specific audiences.
- Contribute to the writing and content development of Sector Standards.
- Develop high-quality written materials, including presentations, briefing documents, departmental documents and program proposals.
- Compile and analyse information about sustainability reporting practices across the world.
- Collaborate in project management tasks when required.
- Other duties as requested

Key competencies / Requirements

- Minimum 3 years' experience working on projects involving research and analysis, preferably with a focus on environmental, social, and economic sustainability issues. Experience may have been acquired in either academic, corporate or public service environment.



- Strong research skills; familiarity with socio-economic and financial databases and bibliographical research; ability to identify data sources and determine their validity; strong logical thinking skills.
- Experience in writing formal or technical documents.
- Technical knowledge of reporting and standards processes, including experience with the design of performance indicators, is a plus.
- Proficient level of written and spoken English.
- Results-focused and able to handle multiple tasks, prioritize, and work to precise timelines.
- Ability to work in an international and multi-cultural setting.
- Ability to work independently and remotely.
- Affinity with the mission and vision of GRI.
