Rabobank also feels that general guidelines require a sector-specific translation to adequately reflect the essence of a company. The large differences in general and sector-specific guidelines reduce the comparability of the reports in the market. This poor comparability of reports is a thorn in the flesh of Rabobank for several reasons. Firstly, this is a stumbling block towards reaching a widely accepted quality level for these reports. Secondly, the present diversity in guidelines and concepts is the most important reason why the questionnaires with which sustainability rating agencies question companies and assess their performance are so difficult to compare.
