

Website Terms of Use

Scope of these Terms

These Terms of Use and the documents referenced herein explain the terms under which you may use the websites operated by the Global Reporting Initiative (GRI) ("we", "our", "us"), whether as a visitor, registered user, training participant, or licensee (collectively, "Users"). Use of our websites includes accessing or downloading content, browsing, registering for courses, or making licensing requests.
