### 1 1. Background

- 2 The GSSB approved the project proposal for the GRI Topic Standard Project for Climate Change
- 3 following its meeting on 16 February 2023.
- 4 In line with the GSSB's <u>Due Process Protocol</u>, the GSSB confirmed its intention to form a multi-
- 5 stakeholder technical committee (TC) to provide technical advice for developing the revised Topic
- 6 Standard.
- 7 This document presents the third and final group of nominated experts for the technical committee
- 8 and its subgroups for approval by the GSSB. The first group of nominated experts was approved in
- 9 the GSSB meeting of March and the second group of nominated experts was approved in the GSSB
- 10 Meeting of April. All the nominated members have confirmed their availability and interest in
- 11 participating in the technical committee and its subgroups.

#### 12 2. Selection process and criteria

- 13 As per the due process protocol, technical committee members are appointed by the GSSB and
- 14 should reflect a balance of multi-stakeholder constituencies.
- 15 With this third and final group of nominated experts the technical committee comprises 13 members
- 16 seconded by 10 subgroup members all together responsible for revising GRI climate change-related
- 17 Standards.
- 18 With the focus on climate change-related topics, different constituencies will have an equal voice in
- 19 the technical committee. The technical committee is divided into subgroups to develop
- 20 recommendations on specific topics as part of the standards development. For the subgroup work,
- 21 technical committee members have seconded colleagues with specific expertise.
- 22 All stakeholder constituencies on which GSSB membership is based do have representation in the
- 23 technical committee or its subgroups. According to the due process protocol, after approval of the
- final TC member nominations in the GSSB meeting of May, the climate change TC will now include
- 25 experts from each constituency on which the membership of the GSSB is based: business enterprise,
- 26 civil society, investment institutions, labor, and mediating institutions. In addition, geographical,
- 27 gender, and cultural diversity is established. The members represent diverse, multi-stakeholder
- 28 backgrounds and bring an excellent combination of relevant knowledge and experience in climate
- 29 change related topics.



- 30 Furthermore, we ensured regional and topic-specific advice and expertise via an extensive peer
- 31 network of experts to support the technical committee and the Standards Division during content
- 32 development.
- 33 In line with the GSSB's Due Process Protocol, the technical committee will report to the GSSB and
- 34 , of dra .ssB for .ss seek guidance and advice whenever required to advance the revision project or when they cannot
