Work Program is out for public consultation ending on 17 February. Stakeholders are responding. Request GSSB to provide comments. All feedback will be discussed in the in-person March meeting.	SD / GSSB
Biodiversity PCP will close on 28 February. Stakeholders have the opportunity to access the draft and provide feedback. Request GSSB to provide comments.	Biodiversity team – Elodie Chene / GSSB
Labor project TC meetings are ongoing, with the fourth due in April. The first public exposure is planned for Q1 2024. Some nomenclature is still under discussion, but the standard's drafting is advancing. For GSSB approval, is the additional TC member representing the Africa region. Topic projects – work continues in the background in terms of scoping for the review of the economic standards – to be discussed further in the March/April meetings. It is a broad field with a different approach and scope from the labor revisions.	SD

The final project proposal has not changed following consultation with GRI Board and Stakeholder Council	Climate project team – Margherita Barbieri
The project aims to revise Climate-related standards to incorporate new issues, such as the transition plan, emissions targets, emissions offsetting, and just transition.	Climate project team – Margherita Barbieri
The project is working to align and collaborate with numerous climate change related initiatives, instruments, standards, and benchmarks.	Climate project team – Margherita Barbieri
The project is expected to start in February 2023, TC nominations will be presented for approval in April 2023, and an exposure draft is planned ultimately for H1 2024.	Climate project team – Margherita Barbieri
GSSB Members Anna Nefedova and Michel Washer will serve as sponsors of the project.	GSSB Members – Anna Nefedova and Michel Washer

Draft project proposal - no feedback was received from the Stakeholder Council and GRI Board.	N/A
Stakeholder consultations produced feedback that resulted in changes to the project proposal.	Financial services team – Claire Dugan
A single portfolio project will develop three Sector Standards – banking, insurance, and capital markets.	Financial services team – Claire Dugan
A summary of the three Sector Standard scopes was presented for clarification.	Financial services team – Claire Dugan
A summary of changes to the project proposal was presented. Reclassifying sectors based on which services are to be included or excluded is focused on where the greatest impacts reside.	Financial services team – Claire Dugan
The technical committee structure will incorporate one committee per sector. They will collaborate through a cross-sector exchange that is essential to address common impacts	Financial services team – Claire Dugan
Engaging with stakeholders to find TC members to fill gaps in the insurance TC and, more generally, members from the Asian region.	Financial services team – Claire Dugan
SD to recruit 2 or 3 colleagues to grow the project team.	SD, HR team
The extended project timeline reflects the complexity of a single portfolio project to develop three Sector Standards.	Financial services team - Claire Dugan

Previous engagement with the sustainable stock exchange agreed with the scoping change. The TC will have stock exchange representation as exchanges can influence what companies will have to report on.	Research, Sector team
	Stock exchanges could be addressed as a revision of this standard or as a separate project.	GSSV
Is it planned to have a longer-term view that real estate investment trusts have more in common with property and construction?	Yes, the research team undertook to deal with real estate investment in a separate property and construction project.	Research team, Sector team
Is it anticipated that draft standards will be submitted as a single package or separately?	For efficiency, the plan is to develop these in parallel rather than one at a time.	Financial services team – Claire Dugan
